Rules & Regulations for 2015-16 Golf Programs

Each program is non-transferable and for the use of cardholder only. Any violation of rule will result in loss of use without refund.

All players will abide by all club rules and policies (see below)

Golf Registration

- All members and guests are required to register for play in the golf shop prior to going on the course and to observe any special instructions given by the golf professional or any of the assistants.

Golf Course Rules

1. Dress Standards: Appropriate golf attire shall be worn at all times. The golf professional shall have the final opinion as to the appropriateness of golf attire.
2. Each player must have a set of clubs and ride an approved golf car during designated times.
3. Only registered golfers are permitted on the golf course. Starting play or practicing mid-course is not permitted.
4. Players are requested to keep pace of play without delay. Your cooperation is appreciated by all golfers.
5. Foursomes shall have preference over singles, twosomes and threesomes.
6. **Club events & Golf outings shall have preference over all play.**
7. Practicing is not permitted on the golf course. Practice greens and driving range are provided for your use.
8. For the pleasure of every golfer, the course should be kept in good condition. Seed boxes are provided on the par 3 holes and sand mixture is distributed from the cart area for the golfers to use. Please replace divots with the sand mixture provided. Ball marks on the green should be repaired and sand bunkers should be raked. Trash receptacles are provided for your convenience.
9. **Should a player break a window or otherwise damage property on or adjacent to the course, please report damage to the homeowner and the golf shop upon completion of play.**

Golf Cars

- Golf cars shall be used at all designated times.
- Golf cars should be operated at all times in a manner as to not damage or destroy the golf course.
 - (1) To preserve the condition of the golf course, there shall be only one car per twosome.
 - (2) When approaching the tee or green, cars should proceed the car path 30 yards from any of these designated areas.
 - (3) Whenever possible, cars should be driven on car paths. Golf cars must remain on the path on all par 3 holes.
 - (4) To operate a golf car, you must be at least eighteen (18) years old with a valid driver's license.
 - (5) Whenever possible, do not follow other car tracks and please avoid soft and wet spots on the turf.
 - (6) Members and members' guests using golf cars shall be held fully responsible for any damage to the course or cars, and shall reimburse Palatka Golf Club for any damage that may be sustained.

Food & Beverage

- Only food and beverages purchased from The Palatka Golf Club are permitted on property.

Course Property

- Bicycling, jogging, skating, roller blading or leisure walking are not permitted on the property.

Payment of Fees

- Annual payment of membership is due upon acceptance of membership rules and regulations and membership application.
